- J. McLauchlan presented Monthly Snapshot see "HOS Report for August 2024 BOD meeting." Most current total enrollment is 35.
- T. Strout presented Treasurer's Report see "2024 August Financial Report RFPCS." Final per pupil payment was received from the state \$24,000. FEMA money also received a little over \$100,000. Received a \$1638 donation for Bingo start-up (RFCPS has also paid over \$3000 for Bingo costs). New bank account was opened at the Credit Union just for Bingo revenue and cost. T. - Minor changes (spelling and grammar fixes, added staff sick time changes that were approved by board last Dec.) to the 2024-25 Staff Handbook were reviewed - see "Staff Handbook 2024-2025 Draft." K. Wakefield moved to approve. T. Strout seconded. Motion carried.
- Policies and forms supporting compliance with the McKinney-Vento Homeless Assistance Act were reviewed – see "McKinney-Vento Package for Board Review." T. Strout moved to approve. K. Wakefield seconded. Motion carried.
- Policy on Sports Related Injuries Emergency Action Plan was reviewed see "EOP for Sports related injuries RFCPS." T. DeTore moved to approve. T. Strout seconded. Motion carried.

Old Business

- Fundraising updates:
 - Grant application update: nothing to report.
 - Dismissed plans for student car wash, plant/bake sale. Consensus favors a community outreach day highlighting re-opening of 1st floor classrooms and advertising our flexible HS program so that costs can be covered by CSP grant. Planned for Sept. 21, 11:00 2:00.
 - Tuesday Night Bingo report: things going well so far but we need more volunteers to help so lots of people know how to run the games. Will have recouped start-up investment by end of Oct. Discussed suggestions for increasing ticket sales and using TV monitors to advertise.
 - MarketBasket lemonade and bake sale Aug. 1, 2 raised \$269.
- Property search update: charter for a new K-12 school was approved by State Board of Ed. this summer to operate here in the MWV area. They may be competition for obtaining the vacated J. Fuller School property that we would like to occupy.
